Working with a minority government

The national political scene changed in June as the federal election produced a minority government, the first in 25 years. All spring CPJ anticipated the election call and quessed at the date, but we were kept waiting. When the call came, CPJ was ready. What's This About Accountability?, our federal election bulletin, alerted concerned citizens to the deeper issues around accountability for one another and encouraged good questions for candidates of all political stripes. 50,000 election bulletins were printed, half of them in British Columbia for inclusion in BC Christian News, Several church papers included the bulletin as an insert. Packages were sent to religious congregations, churches, schools and organizations and individuals connected with CPJ. And still there weren't enough! The document was also posted on our website; lots were downloaded and forwarded electronically.

CPJ kept a careful watch on the new minority government. Would February's budget promises of significant resources for early learning and child-care come through? New ministers were appointed. CPJ was ready to forge new relationships with the likes of Ken Dryden, the new Minister of Social Development. "Now is an excellent time to engage the many questions that cluster around arrangements for the nurturing of Canada's children." CPJ staff communicated this message directly to the minister in Ottawa on several occasions, promoting the needed mix of affordable housing, living

wages and support for early learning as well as adequate, affordable, available child care.

On the refugee front, CPJ provided behind-the-scenes support to KAIROS when sanctuary hit the news. CPJ followed up on this opportune moment with a letter to Immigration Minister Judy Sgro, emphasizing the underlying need for better refugee determination procedures and the unfulfilled promise of a Refugee Appeal Division. CPJ is watching carefully the new agenda with the new minister, Joe Volpe.

Networking with allies and decision-makers

CPJ continues to work with government officials, partner organizations and coalitions, ever growing its relationships and influence. All MPs were personally invited to the 40th anniversary celebration in Ottawa. Related to our refugee policy work, we met with the Canadian Council of Refugees, Citizenship and Immigration Canada, and the Centre for Excellence on Research on Immigration and Settlement, to name a few. We're in the thick of the action on poverty issues with Campaign 2000, the Campaign Against Child Poverty, the National Council of Welfare, and the Interfaith Social Assistance Reform Coalition. We visited the Ontario Deputy Minister of Colleges and Universities and the Premier's Office to successfully urge implementation of student loans for refugees in Ontario,

We spoke to senior leaders of the Salvation Army on "Why Care About Advocacy?" We conducted a "Tools for Advocacy" workshop for the Anglican Church. CPJ is a regular and expected participant in these discussions, grappling with policy, politics and Christian values.

Ola! and exercising electronic citizenship

CPJ released 12 electronic *Ola!* newsletters though the year. Electronic distribution allows *Ola!* to be sent at special moments, such as November 24, the 15th anniversary of the all-party House of Commons resolution to end child poverty in Canada. This mini-*Ola!* encouraged readers to send a quick and easy e-card directly to the Prime Minister and opposition leaders. Another *Ola!* addressed the Alberta election with quick facts and Alberta voices speaking to current issues.

During the year *Ola!* provided *educational* electronic connections to the Caledon Institute paper authored by CPJ telling the story of policy change on student loans, to the Report on Grassy Narrows, to Ernie Regehr's article on why ballistic missile defence is bad news, and to a host of others.
